Call to Order/Roll Call

Chair Sherry Carter-Allen, called to order the regular meeting of the Fair Employment Commission at 4:42 pm on January 8th, 2026 - Meeting Held in Room 110, Peoria City Hall.

New Business:

I. Dr. Andre Allen, Peoria County Government DEI Chief

Dr. Andre Allen provided a summary of his role as the Peoria County DEI Chief. He recognized that intentionality and focus are central to DEI roles. His office worked to support the efforts of the County Strategic Plan Priority (4 pillars). Dr. Allen’s workforce efforts are to mirror the demographic served by the County. The County used the most recent census demographic to make measurements. Dr. Allen discussed several initiatives that his office participated in such as lunch and learns, and community events. Dr. Allen’s office works to make sure that tax payers can see where their money is going. Dr. Allen ended his discussion with a focus on representation and communication for the younger generation. Commissioner Ruffin: Discussed the importance of increasing communication in the younger generation and rising into higher career roles.

Chair Carter- Allen: Expressed that talent has to be sought after. The city requires good faith efforts and inquires about those efforts at the County.

Dr. Allen reported that the County does in fact have similar good faith efforts towards those goals. Dr. Allen also recognized that the pipeline is a major problem that has to be tackled.

Chair Carter- Allen gave recognition to the trades for working diligently to increase younger individuals in the various trades.
